On 5-27-14 FAA advised Mountain Escape LLC, 2711 Centerville Road, Ste. 120, PMB 7016, Wilmington, DE 19808 that in FAAs' letter of January 15, 2014, FAA advised that the registration of PIPER, PA-34-220T, serial number 348233144, had expired and that the

assignment of registration number N202WA was scheduled for cancellation. It was also advised that N202WA could be reserved by the aircraft's last registered owner, otherwise upon cancellation it would be designated as unavailable for a five year period.

As of the date of this letter, no new application has been received by the FAA Aircraft Registration Branch for the renewal of the aircraft or the reservation of the N-number. Accordingly, the assignment of N202WA has been cancelled on this date. Operation of an unregistered aircraft is a violation of 14 C.F.R. 47.3(b) and subject to civil penalties.

NOTE: Registration of N202WA was cancelled by FAA on 5-27-14 due to registration "Expired".
